2.3 Analysis on Initial Assessment

Since 1998 the Woodview Estate has been part of the Attwood Green Regeneration Programme that is managed by a partnership between the Council and Optima Community Association.

To meet the contractual obligations of this partnership, the Council has continued to recycle and re-invest capital receipts arising from the sale its land within the projects boundary to implement an extensive regeneration programme. The sale of Council land at Woodview has generated capital receipts that have funded priority projects to support Woodviews regeneration. These include social and affordable housing, new neighbourhood park, public realm improvements and building and security works at Woodview Primary School.

Through ongoing consultations it has long emerged, local residents support the addition of a new purpose built community centre at Woodview.

This is linked to the strategic outcomes, identified in section A of the initial assesment.

3 Concluding Statement on Full Assessment

There has been ongoing consultation and engagement through the partnership between Council and Optima Community Association and local residents which has jointly seen the Woodview Estate develop in to an assett available to the whole community since 1998.

There has been a previous full Equality Assemnent carried out upon the inital development of Woodview and all subsequent construction on the site has been in consultation with the community.

Subsequently there is no further requirement for a Full Assesment based on this Initial Screening and previous evidence and engagement with the community for the extensive regeneration programme.

These include social and affordable housing, new neighbourhood park, public realm improvements and building and security works at Woodview Primary School.

Through ongoing consultations it has long emerged, local residents support the addition of a new purpose built community centre at Woodview.
